SAYEN'S DISTRIBUTOR TERMS OF AGREEMENT

1. Applicant must be 18 years of the age and above.
2. Upon Sayen accepting the application to be Sayen's distributor, the applicant will automatically be recognized as a distributor of Sayen and will remain valid as long as distributor abide by and conform to the Sayen Distributor Rules & Regulations as stated in Sayen Distributor's Business Manual.
3. Distributor have studied the Sayen Distributor's Business Manual as well as the Direct Selling Act and distributor agree to abide all the operational procedures, rules & regulations therein stated. Distributor acknowledge that any violation of the Terms of Agreement, the Sayen Distributor's code and Ethics, Rules and Regulations or any obligations distributor may have with Sayen, may result in the termination of the distributor membership or other disciplinary action deemed appropriate by the Sayen Management.
4. Distributor membership will be terminated if there is no commission received over 6 months without notice. Should the distributor wish to renew his/her membership in Sayen, he/she is required to submit a new application.
5. Sayen has right to terminate any distributor membership for whatsoever reason(s) in any country by giving 7 day(s) notice, whether in the First Country or any Host Countries, will automatically result in the termination of distributor membership in all countries whereupon all benefits, privileges and recognition of the distributor shall cease immediately.
6. In the process of introducing new recruits and promoting Sayen's products, distributor shall not violated the Direct Selling Act and induce customers by quoting exceptional example, misappropriate money of downline, distributor or customers, or accept any form of corrupt offers.
7. Without prior approval from Sayen Management, distributor shall refrained from:
 - a. Promoting Sayen's products and / or Sayen activities through any form of the advertisement or
 - b. Recruiting new distributor through any media
 - c. Alter any marketing / business plan
8. Sayen reserves the right to accept or reject any application form for any reason at its discretion including applications that contain incomplete, inaccurate, false or misleading information. Any alteration or modifications will be subject to verification.
9. Distributors are solely responsible for the compliance with applicable taxation requirements.
10. At any time, the distributor's action or conduct must not damage Sayen's interest and reputations, otherwise legal action will be taken.
11. To strict business and the legal requirements of the respective countries, Sayen prohibits distributor from the retailing of Sayen's product from First Country products in any Host Countries and vice versa not with standing distributor in the respective countries.
12. The law of Malaysia shall govern this agreement.
13. Distributor agree to keep abreast and be bound by all such changes and updates from time to time.
14. Sayen reserves the rights to amend the Terms of Agreement and Sayen Distributor's Business Manual without any prior notice or explanation.
15. When the agreement is cancelled, the company will buy back a new retail product which are not used, purchased by distributors in the past six months, at 90% of original price after deduction of any appropriate expenses and legal claims, if any. For resale, all products must be in original condition and has not been used, can be sold in the market. (this do not include seasonal products and limited promotion items) Products must be delivered to the place of operations included with the product Return / Replacement form at distributor cost. Cost of the company for bonuses or commissions for any prizes or products which Sayen awarded to a distributor beside the original purchase, courier cost or other types owing to the company's distributor, will be subtracted from the total purchase price. Distributor who return the goods to the company will not be accepted by the company as a distributor again within 12 month(s) period.
16. I agree that I has the right to reject the application within 10 working days from the date the application is made. Cooling period of six months is required before I can join Sayen as a distributor.
17. By filling out and submitting this form, you are deemed to have given consent to the Company to collect, process, use and retain your personal data for the sole purpose of registering and maintaining the Distributorship of the Company and for any other purpose related and incidental to the said Distributorship.
18. The company undertakes not to share your personal data with any third party unless for a purpose related to Distributorship or if so requires by the Malaysian Law.
19. Any other kinds of disclosure will only take place upon receiving your express consent.
20. While the Personal Data Protection Act 2010 (the "Act") affords you with the right to withdraw such consent given to the Company at any time, the withdrawal of such consent may result in the cessation of your Distributorship at the Company.
21. Pursuant to the Personal Data Protection Act 2010 (the "Act"), you are entitled to request to access and update your personal data retained by the Company by contacting its Personal Data Protection Manager.
22. In compliance with the Act, you are required to update the Company on any charges to your personal data as and when they occur by contacting our Personal Data Protection Manager.
23. All your personal data will be retained by the Company throughout the time of your Distributorship here.
24. All your personal data will be purged from our system within six months from the time of your cessation of Distributorship unless otherwise required by the Malaysian Law.

SAYEN GLOBAL SDN BHD- PDP CONSENT CLAUSE

For the purpose of the following sections, the term “personal data” shall adopt the meaning as defined by the Personal Data Protection Act 2010.

In the relation to any personal data provided personally by the data owner or via a third party (collectively known as the 'data provider') to Sayen (the company):
